A center for the collection and treatment of End-of-Life Vehicles (ELVs), it is a member company of CAR - Confederazione Autodemolitori Riuniti - United Confederation of Car Wreckers; it is also a PRA (DVLA)-authorised platform for dealing with cancellation procedures.

For over 40 years in the automotive field, **Pomili Demolizioni Speciali Srl** complies with all the strict criteria on transfer, dismantling and scrapping of ELVs (including those laid down by the ELV-U.N.R.A.E. Unione Nazionale Rappresentanti Autoveicoli Esteri - National Union Of Foreign Car Representatives) and, since January 2018, has held the AVEI (Autodemolitore Veicoli Elettrici o Ibridi - Electric Hybrid Vehicle Wrecker) qualification for the correct End-of-Life management of electric or hybrid vehicles.

The acquisition of innovative knowledge and expertise on electric and hybrid vehicles in the car wrecking business guarantees specialized services and a competitive partnership with automotive brands.

To achieve this qualification, **Pomili Demolizioni Speciali Srl** has proved, in third-party audits, to meet technical, operational-managerial and training requirements.



M.U.D. - Modello Unico di Dichiarazione Ambientale (Single Environmental Declaration Model), supply, drafting and compiling of the Waste Identification Form).



**Pomili Demolizioni Speciali Srl**, service center and branch office of Li.C.S.A.- Ecologia, is authorized to keep loading and unloading registers for special waste producers whose annual production does not exceed 20 tonnes of non-hazardous waste and 4 tonnes of hazardous waste. The latter can therefore also fulfill the obligation to keep waste loading and unloading registers through the relevant business associations or service companies directly subordinated to them.

#### Pomili Demolizioni Speciali Srl can:

- enter into clear, simple and transparent agreements with all customers;
- provide tailor-made services for each type of customer need and request (pick-up schedule, times, days, etc.);
- carry out, through authorized and certified laboratories, sampling services and chemical-physical analysis on waste;
- provide assistance and direct environmental consulting for any problem on waste management;
- rent and deliver to its customers approved: containers/containers/tankers/dumpsters/compactors of different sizes and capacities for storing waste prior to collection.

In addition, the company carries out waste intermediation activities (registration in the National Register of Environmental Managers - Category 8), having established excellent relations and partnerships with waste storage/recovery/disposal facilities over time.



# BULKY URBAN WASTE COLLECTION What is bulky waste

Bulky waste is defined as large municipal waste that cannot be transported by car, consisting of everyday household and/or furniture items (refrigerators, furniture, tables, mattresses, etc.) as well as durable goods such as WEEE (Waste Electrical and Electronic Equipment), which by type or size cannot be collected separately door to door.

### Whom we address:

- door-to-door collection management for municipalities and public bodies;
- support to companies contracting urban hygiene services;
- the service is reserved for households;
- those who do not have a vehicle for transporting bulky waste to the ecological islands.

The following activities are planned as part of this service:

- collection of bulky items from the street level following their placement by the user near his or her house number;
- transport and delivery of the above-mentioned material to the relevant Municipal Collection Center;
- transport and delivery of the above-mentioned material to authorized recovery/disposal facilities or Re-use Preparation Centers.



SCRAPPING, TREATMENT AND STORAGE OF ELECTRICAL
AND ELECTRONIC EQUIPMENT (WEEE) AND FERROUS AND
NON-FERROUS MATERIALS

New operational site for **Pomili Demolizioni Speciali Srl** in the waste management sector located at Via Benito Graziani, 3 in the municipality of Cittaducale (RI), in the zone of Santa Rufina, to be more precise in the industrial area.





The company is authorized to treat and store the following waste:

- scrapping of end-of-life equipment (WEEE) containing hazardous substances and their components, as listed in Annex II of Legislative Decree No. 49 of 14 March 2014, with storage (R13) and reuse only;
- scrapping for recovery, recycling, reuse of end-of-life equipment (WEEE) and their components, as listed in Annex II to the same Legislative Decree 49/2014, not containing hazardous substances;
- scrapping for recovery, recycling, reuse of non-hazardous waste (scrap metal), in the types set out in Ministerial Decree of the 5th February 1998.

# ASBESTOS REMEDIATION and CONTAMINATED SITES

**Pomili Demolizioni Speciali Srl**, regularly enrolled in the National Register of Environmental Managers in categories/classes 9D and 10B-C, operates throughout the country and is the optimal technical-organizational and operational support to deal with problems, both in the civil and industrial fields, of:

- remediation of contaminated, decommissioned and non-contaminated sites and assets;
- removal, remediation and encapsulation, with specific products for removal and disposal, of manufactured articles containing asbestos in a compact or friable matrix;
- confinement, coating and overcoating of asbestos-containing artifacts of compact or friable matrix;
- conservative encapsulation of asbestos-containing manufactures of compact or friable matrix;
- reclamation of sites, assets and land containing asbestos;
- risk assessment and evaluation of the state of preservation of asbestos-cement roofs in accordance with the General Health Directorate Decree no. 13237 of 18/11/2008 with the definition and specific certification of the Degradation Index (D.I.).

Only as examples, the artifacts in which it is possible to find the presence of asbestos are:

- · covers;
- chimneys;
- glues:
- rainwater pipes;
- flues;
- insulating panels;
- pipelines;
- flooring;
- infill panels;
- tanks:
- sheaths;
- plasters;

- reservoirs;
- · insulation;
- various plates;
- · containers;
- gaskets;
- etc.
